District Wide Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

The Preble Shawnee Local School District agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with Section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- Consistent with Section 1118, the school district will work with its schools to ensure that the required school-level parental involvement policies meet the requirements of Section 1118(b) of the ESEA, and each include, as a component, a school-parent compact consistent with Section 1118(d) of the ESEA.
- The school district will incorporate this district-wide parental involvement policy into its LEA plan developed under Section 1112 of the ESEA.
- In carrying out the Title I, Part A parental involvement requirements, to the extent practicable, the school district and its schools will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under Section 1111 of the ESEA in an understandable and uniform format and, including alternative formats upon request and, to the extent practicable, in a language parents understand.

- g. Parents will receive timely information via parental meetings, open houses, newsletters, and conferences
- 4. The Preble Shawnee Local School District will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs:
 - a. Head Start
 - b. Preble Shawnee Local School District Pre-School
- 5. The Preble Shawnee Local School District will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background).  - B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:
 - a. Title I Parent Meetings
 - b. Surveys
 - c. Parents Lacking literacy skills or whose native language is not English will have Title I information relayed in an appropriate manner
 - d. Parents will receive timely information via parental meetings, open houses, newsletters, and conferences
 - C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - a. Title I Parent Meetings
 - b. Discussion at Board of Education Meeting
 - c. Surveys
 - d. Teachers in-serviced on parent communication strategies
 - D. The school district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start and the Preble Shawnee Pre-School Classrooms.
 - E. The school district will take the following actions to ensure that information related to the school and parent programs, meetings and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - a. Title I Parent Meetings
 - b. District Leadership Team parent representation
 - c. Parents Lacking literacy skills or whose native language is not English will have Title I information relayed in an appropriate manner
 - d. Parents will receive timely information via parental meetings, open houses, newsletters, and conferences

The Preble Shawnee Local School District will build the schools' and parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
